When reflecting on the last fiscal year, the area where we experienced the most concentrated growth was right outside our front door. Essentially we worked to develop programs in the community to meet the evolving needs of Harrisonburg and Rockingham residents. This is notable because we operate predominately as a clinic-based agency for most adult services and over 50% of our children's services. However, as we worked with community stakeholders around the development of new programs, it became apparent that going out to the individual is ideal in some cases. For example, we began a Crisis Intervention Team Assessment Center at Sentara RMH Medical Center, initiated both adult and children's mobile crisis services

and added peer support services which are all highlighted in this report. There are certainly benefits to having both clinic and community services available, depending on the need.

In addition to providing established quality services to both children and adults, we partnered with Harrisonburg City and Rockingham County Public Schools, the Rockingham-Harrisonburg Regional Jail, the Harrisonburg Redevelopment & Housing Authority, Sentara RMH Medical Center, Rockingham County Sheriff's Office, and Strength in Peers to develop new programs through joint ventures utilizing local, state and grant funding. It has truly been exciting to have these conversations around what could be possible when we work together.

Children's Mobile Crisis

In December 2015, two clinicians began providing mobile crisis services in the community to children under 18 years of age. We have received over 330 referrals for services and interacted with over 200 families in the first 6 months.

Behavioral Health and Wellness

This program is predicated on developing strong partnerships in the community through training and education on Mental Health First Aid, Suicide Prevention, and promoting healthier social norms in our youth. This work is accomplished by working closely with James Madison University, Bridgewater College, the Virginia Health Department, the Strong Families Great Youth Coalition, and both Harrisonburg City and Rockingham County Public Schools.

School Based Services

At the request of both the Harrisonburg City and

Rockingham County Public Schools, we have increased the number of hours our clinicians provide in-school early intervention with students around situational stress-related issues.

Expanded Jail Services

One-time funding allocated by Harrisonburg-Rockingham CSB, the Rockingham County Board of Supervisors and the Harrisonburg City Council allowed for an 18-month pilot of a licensed mental health clinician in the Rockingham-Harrisonburg Regional Jail for 20 hours to provide assessment, evaluation and brief individual counseling for the purposes of crisis stabilization. Between January 2015 and July 2016 services were provided to over 500 individuals at the jail.

Partnership with Sentara RMH

The Crisis Intervention Team Assessment Center (CITAC) opened on December 1, 2015 in the Sentara RMH Medical Center Emergency Department with the goal of reducing the number of hours law enforcement officers are spending in the emergency department during an Emergency Custody Order.

Ex-Offender Care Coordination

The grant-funded Community Services and Connections for Ex-Offenders Program is fully staffed with a case manager in the Rockingham-Harrisonburg Regional Jail and a therapist located at Harrisonburg-Rockingham CSB. This program, in partnership with Strength in Peers and the Harrisonburg Redevelopment and Housing Authority, started February 1, 2016 and has already assisted 15 ex-offenders with the difficult transition of being released to the community; specifically linking those persons to substance use services and other resources in the community.

Mobile Crisis Team Launched

The Adult Mobile Crisis team, funded through October 2018 by federal grant and local match monies, became fully operational on July 1, 2016. This 20-hour service is comprised of a licensed clinician and a law enforcement officer providing brief assessments and crisis intervention in the community.

Partnership with Housing Authority

In partnership with the Harrisonburg Redevelopment and Housing Authority, Harrisonburg-Rockingham CSB hired a Peer Specialist beginning January 2016. This position is based at Commerce Village 25 hours per week to assist residents in connecting with community supports and resources.

High Level Services

Steve first started experiencing symptoms in his early 20s. They started as mild hallucinations but progressed to delusions and suicidal thoughts. He lost his job, his wife, and his kids. After his second psychiatric hospitalization, Steve was feeling hopeless. Steve came to the CSB for an intake, and was connected to case management and psychiatric services. He started on his road to recovery and benefited from stays at **Arbor House Crisis Stabilization** Unit to further his knowledge of coping skills. Steve now has a place to stay, sees his kids every weekend, has insurance and been awarded disability income.



Mental Health Services

Our licensed and professional staff provide an array of services to children and adults struggling with mental health issues. We offer services that include traditional mental health therapy, case management, clubhouse (psychosocial rehabilitation services), and residential supports to help our clients on their road to recovery.

Substance Use Services

Our client-centered treatments provide individualized, need based, and strength based therapy and case management services for individuals with substance use issues. We support individuals in a traditional outpatient setting, link individuals to needed community services, natural supports and monitor the delivery of services.

Psychiatric Services

For children and adults dealing with mental health issues, our psychiatric team provides medication evaluation and management services. Our team consisting of psychiatrists, psychiatric nurse practitioners and psychiatric nurses work together with our mental health treatment providers to support individuals with their treatment goals.

Crisis Services

Our crisis services are available 24 hours per day, 7 days a week for individuals and families experiencing behavioral health and/or substance use crisis. We are equipped with on call emergency services staff, a crisis stabilization residential unit, mobile crisis team, and an assessment center located at Sentara RMH Medical Center.

Developmental Services

Our case managers work with adults and children diagnosed with a developmental disability. Using person-centered practices, our team assists clients by assessing their needs, coordinating care, and linking clients to needed community services. Possible services include residential, medical, behavioral, day support, vocational services, and all services available under Virginia's Medicaid Waiver programs.

Behavioral Health and Wellness


We are passionate about making mental health and substance abuse prevention an important component of the services we provide to our community. Some of the services we provide are tobacco merchant education, Mental Health First Aid (MHFA), and Applied Suicide Skills Intervention Training (ASIST). We also partner with Sentara RMH Medical Center's Parent Education and Support Program (PEAS) to provide parenting education classes to community members.

Comparative Budget Overview Fiscal Years 2016 And 2017




