The November 10, 2020 Board meeting was called to order at 7:16 a.m. by Chair Deborah Bullis.

- 1. **Announcements and Introductions:** Guests were introduced as listed above.
- 2. Approval of October 13, 2020 Board Minutes: Incorrect Board Chair name was noted. MR. MONGER MOVED THAT THE OCTOBER 13, 2020 BOARD MINUTES BE APPROVED AS AMENDED. MS. BLAND SECONDED THE MOTION AND THE MOTION CARRIED.
- 3. **BY-LAWS FOR HRCSB:** Ms. Harrison presented a revised draft of the By-Laws for review. Further clarification by legal counsel was recommended regarding participation during a declared State of Emergency. Revised By-Laws will be presented for action at next Board meeting.
